WHY DO I WANT A COPY OF MY CREDIT REPORT?

Your credit report has information that affects whether you can get a loan and how much you will have to pay to borrow money. It is recommended that you request a copy of your credit report to:

- Make sure the information is accurate, complete, and up-to-date before you apply for a loan, buy insurance, or apply for a job where your credit may be checked.
- Help guard against identity theft by checking for any inaccurate information, which could affect your ability to get credit, insurance or even a job.

Minimum opening deposit is \$5.00 for Regular Share, Christmas Club and IRA Share Accounts. Minimum opening deposit for Share Draft Accounts is \$50.00. Minimum balance to earn the APY is \$100.00 for Regular Share and Share Draft Accounts. Dividends are accrued monthly and credited to your account on the last day of each month.

For term share certificates, a penalty will or may be imposed for early withdrawal. Maintenance or activity fees could reduce the earnings on the account.

**Dividends for Christmas Club Accounts are credited to your account annually on 11/01.*

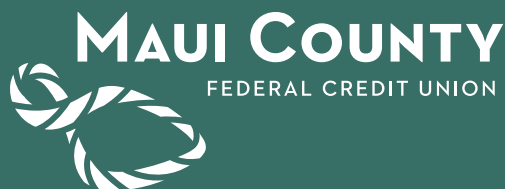
