Freeze Your Credit for Free

A new federal law that was passed on September 21, 2018 now allows consumers to request a freeze on their credit at no charge. With the increase in identify the ft, this is a great option to restrict access for unauthorized accounts being opened up in your name. Have a child under the age of 16? You can also put a freeze on their credit as well.

In addition, fraud a lerts will now remain in place for one year (they used to last only 90 days). When putting a fraud a lert on your credit report, the creditor has to verify your identify.
